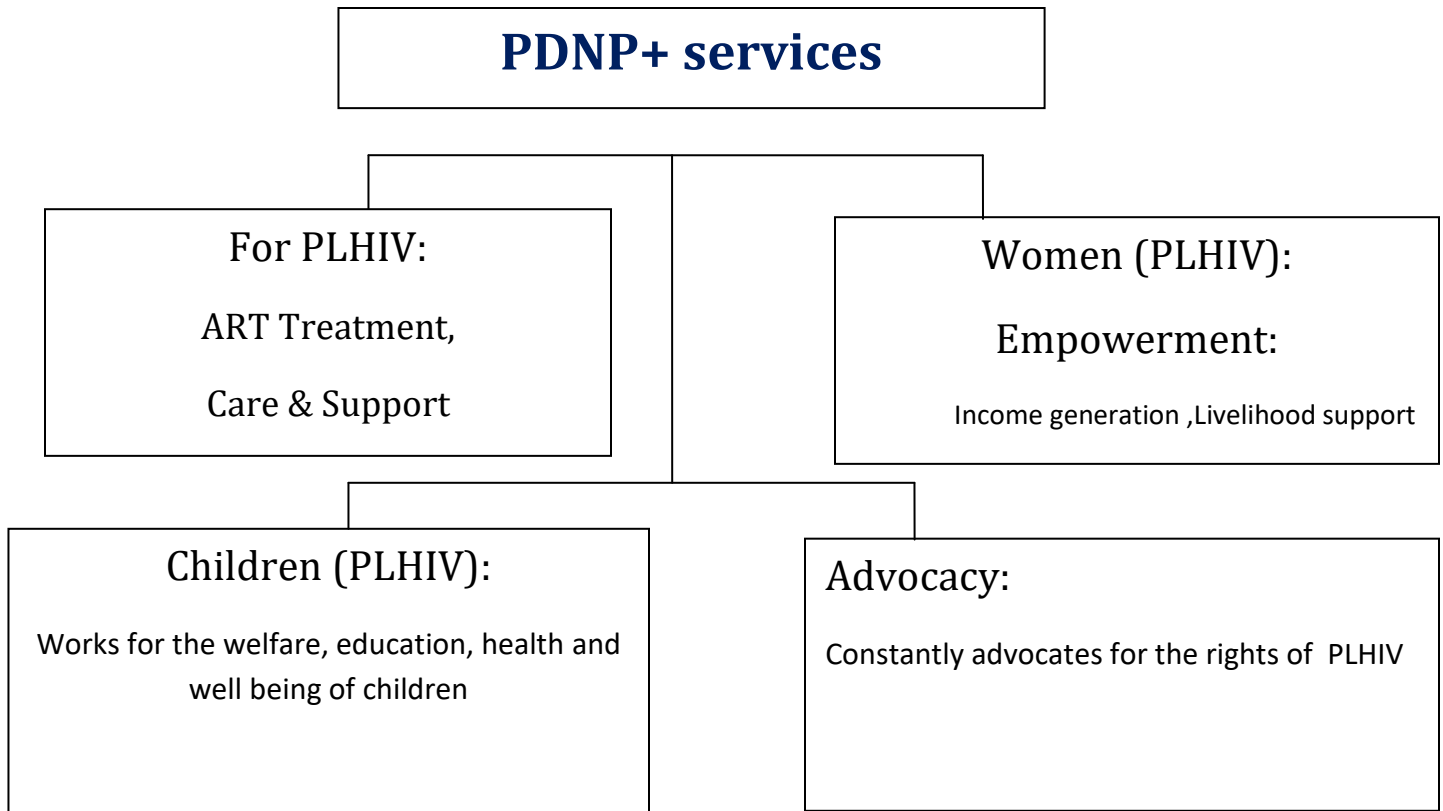



ORDER U/S 12AA OF THE INCOME-TAX ACT.

The Society, herein known as PERAMBALUR DISTRICT NETWORK FOR HIV POSITIVE PEOPLE (PDNP+), No: 64/4-B, 1st Floor, Madharsha Road, Near BSNL Office, Old Bus Stand, Perambalur- 621 212 was registered under the Tamil Nadu Societies Registration Act, 1975 vide Certificate No.45/2004 dated 02/07/2004. The Society was created with the main objects to improve the quality of life of people living with HIV / AIDS (PLWHA) to promote positive image and give visibility of PLWHA, in order to counter the fear, ignorance, discrimination and prejudice that they face; to develop networking with PLWHA groups and other organizations with in HIV / AIDS field; to provide counseling services for HIV infected and their family members; to create awareness about HIV/AIDS for valuable and general population etc.


2. The Society has furnished an application on 29/06/2010, in Form No.10A, under section 12A(a) of the Income-tax Act,1961, seeking registration u/s 12AA of the Act.


3. After due consideration of the objects of the Society, the genuineness of the activities carried out by the Society the registration is hereby granted u/s 12AA as Public Charitable Society. Since the application for registration has not been furnished within the prescribed time, the registration is hereby granted to the applicant Society with effect from the first day of financial year in which the application has been filed i.e., 01/04/2010. The Registration No. of the Society is 25/2010-11.

4. The applicant Society shall abide by the provisions of Section 139(4A) of the Act and all other provisions of the Act, as may be applicable from time to time.

5. If at any stage it is found that the activities are either not genuine or are not being carried out in accordance with the objects, the registration granted may be cancelled, in terms of the provisions of Section 12AA(3) of the Act.

6. However mere registration u/s 12AA does not entitle the applicant, the exemption under the provisions of section 11 to 13 or any provisions of the Income-tax Act, the Assessing Officer is free to make any inquiries in this regard as deemed fit.

After due consideration of the application and the enclosures thereto and being satisfied that the conditions laid down under section 80G(5) (i) to (v) are prima facie satisfied, approval u/s 80G(5) is hereby accorded from 05/10/2010. The approval u/s 80G will accordingly apply to the donations received after this day. 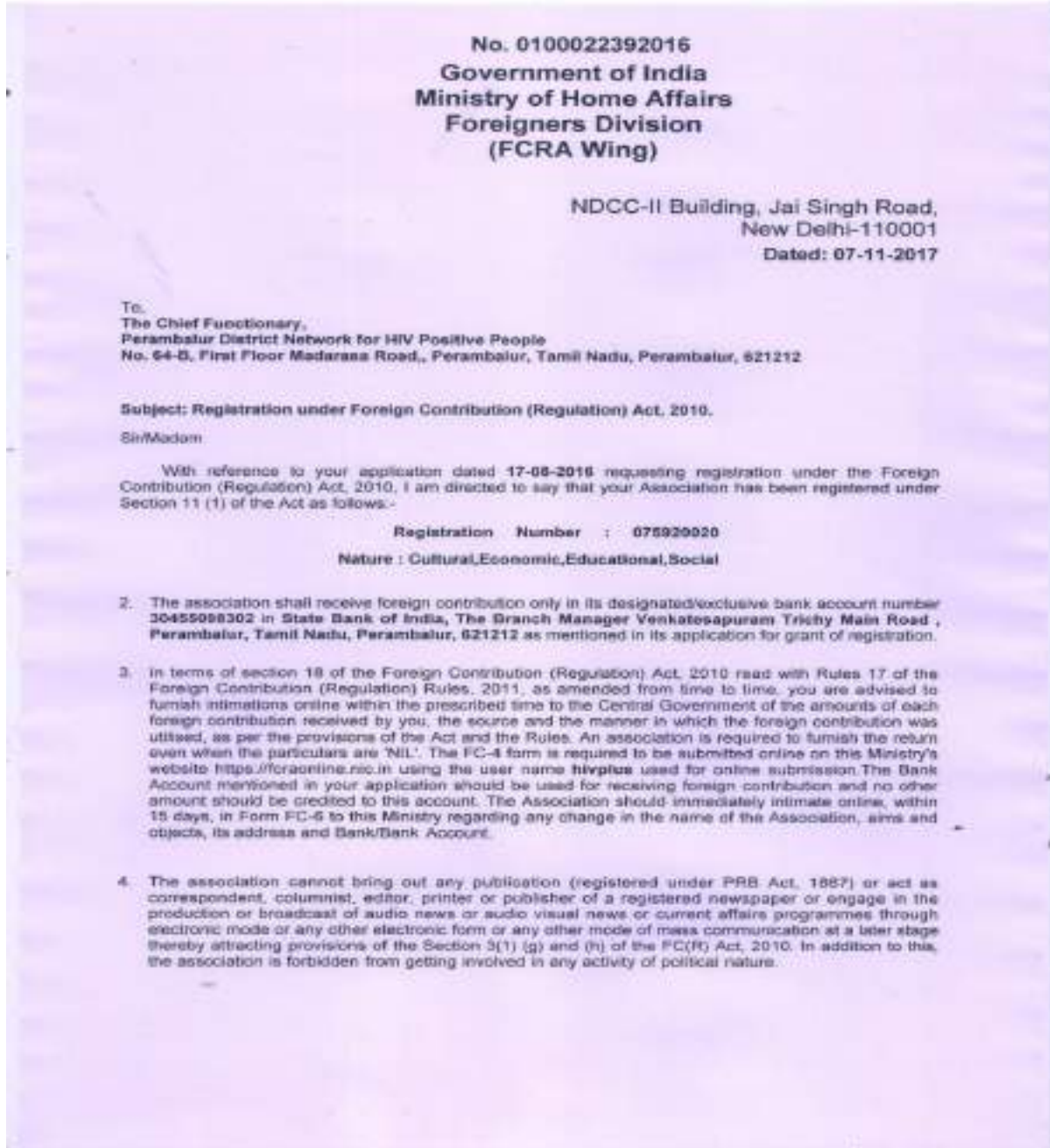

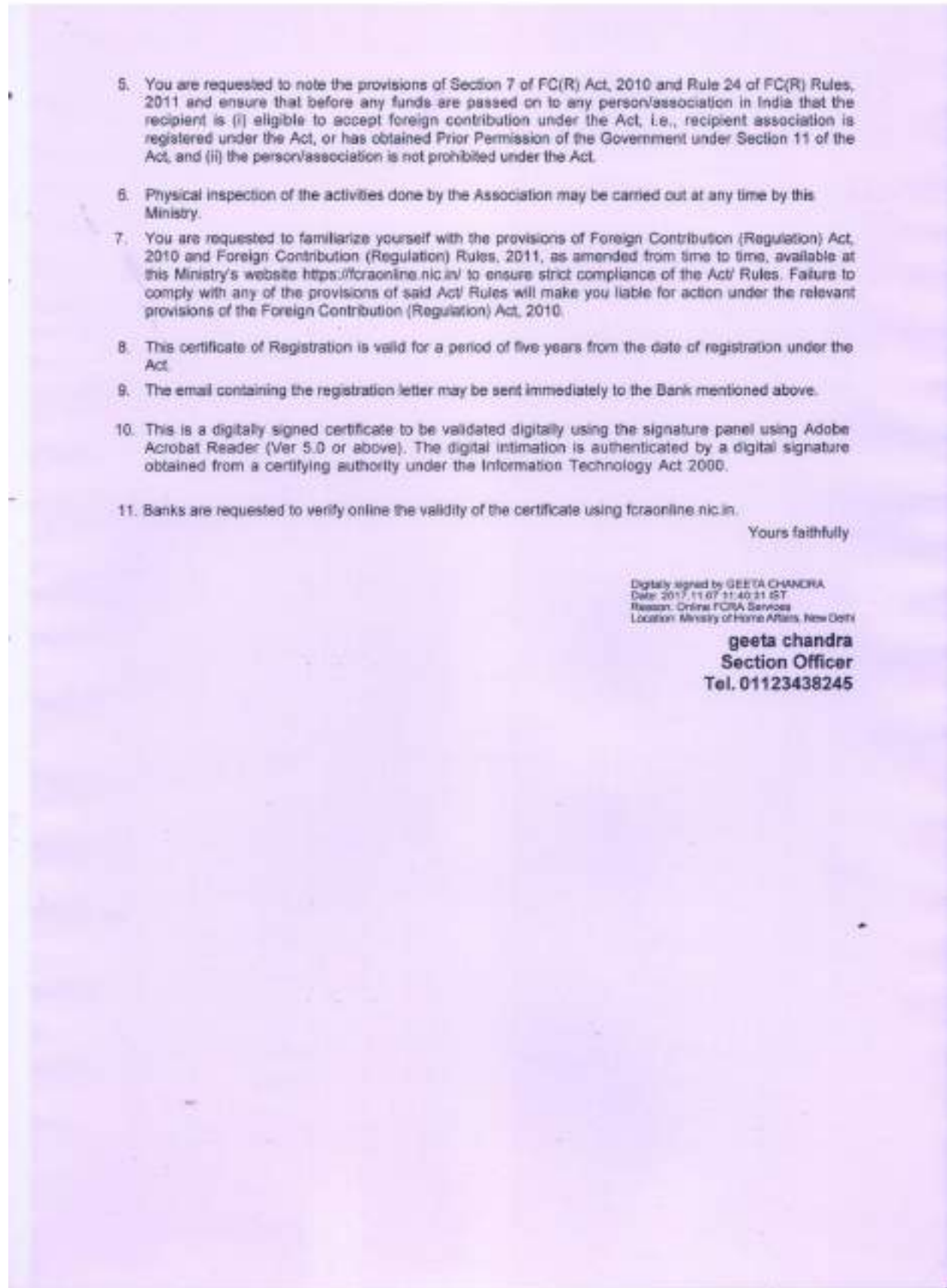
